

## **HAYMERLE SCHOOL HOME – SCHOOL AGREEMENT 2019 to 2020 –**

Working in partnership with pupils, parents, teachers and school support staff.

TOGETHER - We will:

- Work together to sort out any problems that may arise, e.g. attendance, behavioural, educational.
- Enable our children to develop as responsible members of the school and local community.
- Encourage each child to engage with shared school rules and values.
- Support children's learning to help each individual achieve their best.
- Celebrate children's achievements in and out of school.
- Support regular attendance.
- Value punctuality.
- Work to combat racism.
- Work against bullying.
- Follow safeguarding procedures according to school policy: Haymerle School has a **Safeguarding Policy 2019/20** in place. We have a duty of care to safeguard our pupils which may require designated school staff to contact external agencies in exceptional circumstances or should they have concerns regarding a child's safety or well-being. **You can access the Safeguarding Policy on our school website or ask the school administration Team to send home a copy.**

SCHOOL -We will:

- Provide an environment conducive for learning.
- Encourage all children to achieve in all aspects of development – behaviour, social skills and learning.
- Contact parents/guardians if there is a problem with attendance, punctuality or behaviour.
- Inform parents/guardians of any concerns or problems that affect their child's work and learning.
- Set, mark and monitor homework, in accordance with Haymerle's school policy.
- Provide a forum for parents to meet school staff and view school policies.
- Arrange parents' days and provide an annual report.
- Keep parents informed about school activities and give adequate notice of meetings.
- Encourage children to take care of their surroundings and others around them.
- Encourage children to follow our school rules.
- Contact parents if their child is unwell at school and where appropriate request that the child is collected if the child is not well enough to be at school
- **Provide Religious Education in accordance with the agreed syllabus from which parents may choose to withdraw their child (please contact the school as needed).**
- **Provide a daily act of collective from which parents may choose to withdraw their child (please contact the school as needed).**
- **Provide sex and relationships education SRE. (age appropriate and differentiated and appropriate for the ability and needs of our pupils) from which parents may choose to withdraw their child (please contact the school as needed)**

**PARENTS/GUARDIANS – I / We will:**

- Ensure that my child attends school regularly
- Provide an explanation if my child is absent.
- Collect my child promptly from the school bus
- Bring my child to school on time- (9.20am).
- Be punctual collecting my child at the end of the school (3:15pm) day or from their drop-off point from the bus round.
- **Not to book holidays in school term time. I understand this will not be authorised by the school.**
- Provide evidence of any special circumstances that may result in my child's absence for reasons other than school other than sickness.
- Inform school and transport **in advance** of alternative arrangements dropping or collecting my child
- Let the school know promptly about any concerns or problems that may affect my child's work or behaviour.
- Support my child in homework and other opportunities for home learning, in accordance with School policy.
- Attend parents' meetings and discussions about my child's progress.
- Attend school events where possible.
- Get to know about my child's life at the school.
- Support my child to be tidy in appearance.
- Support the policies of the school.
- Ensure my child takes PE and swimming kit to school as appropriate.
- Follow the established procedure to voice concerns.
- **Ensure I provide the school with up to date emergency contact information and telephone numbers. (At least 2 emergency contact numbers are required)**
- **Not send my child to school if they are unwell.**
- **Agree to collect my child following contact from school regarding a pupil being unwell at school**
- Inform the school if I wish child to be withdrawn from daily acts of collective worship.
- Inform the school if they wish their child to be withdrawn from sex and relationship education.

**CHILD** - with the help of my teachers and family I will –

- Keep the school rules and be responsible for my behaviour.
- Be polite and helpful.
- Be kind and considerate to others both in the classroom and in the playground.
- Take care of the school and everything in it.
- Listen to what others tell me.
- Work hard and allow everyone else to do so too.
